8.	Harmanjot Singh Sidhu (General Surgery)	Evaluation of Surgical Apgar Score in Prediction of post-operative complications in abdominal surgeries: A prospective observational study	<ul style="list-style-type: none"> Attach the surgical Apgar score template.
9.	Shreyans Jain (General Surgery)	Comparison of 3D Endovision vs 2D ultraHigh definition 4K Endovision system for Laparoscopic hernia and Gall bladder surgery: a randomised Controlled Trail	<ul style="list-style-type: none"> Primary objective is unclear and poorly phrased: needs rewording for clarity. Avoid repetition like “using.....using.” Secondary objectives are too subjective. For example, “time taken for procedure; can be confounded by surgeon skill. To address this, either: Use the same surgeon for both techniques, or Control for operator variability in your analysis. Too many abbreviations are used throughout. Only a few are spelled out at first use: all abbreviations must be defined clearly when first introduced in each section. Inclusion & Exclusion Criteria Point 3 under both criteria relates to surgical skill, but that’s not clearly stated. Revise to make the relevance to surgical skill explicit. One page missing in the PIS. Correct the Certificate Candidate sign missing on submission of Thesis protocol Modify group name as suggested Complete PIS form in Hindi/Punjabi language.






