- 1. <u>Age Limit:</u> Cutoff date to determine eligibility in terms of upper age limit and all other qualifications and experience of candidates will be the last date of submission of application form in the link mentioned in the application process i.e., 24 Aug 2022.
  - (i) In the case of OBC candidates it is relaxable upto a maximum period of three years beyond the Upper age limit. In the case of Persons with Benchmark Disabilities (PwBD) candidates, this is relaxable upto maximum period of Ten years for General Category, Thirteen years for OBC category candidates.
  - (ii) **To be eligible for selection** for these posts, the candidate should pass the essential qualification and experience till **24 Aug 2022** will be considered.
  - (iii) The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview.
  - (iv) No age relaxation would be available to reserved category candidates applying for unreserved vacancy.
- 2. On the day of Interview, the candidate is required to be present 'in person' with all original certificates in Recruitment Cell, Ground Floor, Admin Block, Medical College Building, AIIMS Bathinda before along with:
  - (i) Residence Proof
  - (ii) Age Proof

**Note:** Candidates belonging to SC/ST/EWS category can still apply but they will not be eligible for any concession/relaxation etc.

The transaction reference number and the date of transaction should be mentioned in the application form. No application fee is applicable for person with disability (PWD) candidates. **This fee once remitted will not be refunded under any circumstances or adjusted.** Applications without the prescribed fee would not be considered and summarily rejected.

- 4. The candidates are advised to see the institutional web site for any additional information and confirm about date and time / venue before coming. No personal / by post information will be sent.
- 5. <u>Selection Procedure:</u> The selection will be on the basis of the interview and if the number of candidates is more, written exam may be conducted for shortlisting for the interview or any other method found suitable by the competent authority. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection. Candidates are requested to visit institute website regularly for any updates on recruitment/selection process.
- 6. <u>Tenure:</u> The appointment is purely on contract basis initially for a period of 06 months and extendable up to maximum 2 years or till regular appointment is made against these posts, whichever is earlier. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the Institute OR for continued contractual appointment, which may be renewed or terminated as per policy/rule/need of the Institute. However, the contractual appointment shall not be extended beyond the period of two years and if the contract is not extended further, the same will lapse automatically.
- 7. **<u>Remuneration:</u>** Consolidated remuneration shown against each post shall be given to contractual appointee after statutory deductions.
- 8. The appointee shall not be entitled to any benefit like Government Accommodation, Provident Fund, deduction of NPS Subscription, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the government servants, appointed on regular basis.
- 9. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent staff of AIIMS Bathinda.

- 10. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period.
- 11. The appointment to the said post will be subject to medical fitness from the competent Medical Board, for which he/she shall be sent to the designated medical board of the AIIMS, Bathinda.
- 12. <u>Expiry of Contract:</u> The contract will automatically expire on completion of 06 months. However, it may be renewed further on the basis of satisfactory performance report. The contractual appointment can be terminated at any time by the Institute. The appointee can also leave the Institute by giving 30 days' notice or salary in lieu of this notice period or for the period of which notice falls short of one month.
- 13. <u>Leave:</u> The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.
- 14. The competent authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- 15. Canvassing of any kind will lead to disqualification.
- 16. Eligible candidates can apply for the more than one post. In such case separate application and prescribed fee should be deposited for each post.
- 17. The candidate may have to work in shifts and can be posted at any Place/Department of the Institute.
- 18. No travelling or other allowances will be paid to the candidate for Interview/Joining for the post.
- 19. The candidate should not have been convicted by any Court of Law.
- 20. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
- 21. Other conditions of service will be governed by relevant rules and orders issued by Govt. of India from time to time with regard to contractual employees.
- 22. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable to be removed from services and such action will be taken as the appointing authority may deem fit.
- 23. The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard.
- 24. - 26. The candidates must ensure that they fulfill eligibility criteria. Candidates are advised to satisfy themselves before applying that they possess at least the essential qualification laid down for the various posts. No enquiry for advice as to eligibility will be entertained.
- 27. Interim correspondence will not be entertained and replied to.
- 28. All the original certificates/documents will be verified before the time of interview.
- 29. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification. For posts having experience as an Essential Criteria, the experience which has been acquired only after obtaining Essential Qualification, will be considered as valid.
