c. SELECTION PROCEDURE:

In case the numbers of applicant are large, the selection committee of the Institute may devise a criteria for short-listing the candidates, which may include holding of

written examination.

- 2. Only the eligible candidates/ shortlisted candidates will be called for interview. However, the same would be provisional subject to fulfillment of all requirements failing which he/she will not be allowed to appear for interview.
- 3. Interview letters will be sent by through email ONLY and the complete interview schedule will also be made available on website also.
- 4. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 5. The information regarding eligibility/ shortlisting of candidates will be published on the website of AIIMS, Bathinda only.
