(i) **To be eligible for selection** for these posts, the candidate should pass the essential qualification and experience till **21 Apr 2023** will be considered.

(ii) The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview.

5. **Selection Procedure:** The selection will be on the basis of the interview and if the number of candidates is more, **written exam may be conducted for shortlisting for the interview or any other method found suitable by the competent authority. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.** Candidates are requested to visit institute website regularly for any updates on recruitment/selection process.

6. **Leave:** The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.

TERMS & CONDITIONS :-

7. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.

8. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.

9. The appointment is purely on contract basis for a period of 11 (Eleven) months or till such time the regular appointments against these vacant posts are made, whichever is earlier, with effect from the date of joining. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.

10. If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.

11. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.

12. The candidate should not have been convicted by any Court of Law.
