a. SELECTION PROCEDURE:

- 1. The application of the candidates which will be received within prescribed date and time and who submit the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible candidates will be called for personal interview before the Standing Selection Committee of the Institute. In case the numbers of applicant are large, the selection committee of the Institute may devise a criteria for short-listing the candidates, which may include holding of written examination.
- 2. Only the eligible candidates/ shortlisted candidates will be called for interview. However, the same would be provisional subject to fulfillment of all requirements failing which he/she will not be allowed to appear for interview.
- 3. Interview letters will be sent by through email ONLY and the complete interview schedule will also be made available on website also.
- 4. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 5. The information regarding eligibility/ shortlisting of candidates will be published on the website of AIIMS, Bathinda only.
