Roles and Responsibilities of Staff:

1. Senior Palliative Medicine Doctor (One):

- Carry out comprehensive patient assessment and develop a medical management plan.
- Manage symptoms like pain, nausea, vomiting, and constipation using pharmacological interventions.
- To take daily ward rounds and discuss with senior palliative care physician and Project Lead.
- Manage complex palliative care cases, including patients with multiple comorbidities or challenging symptoms.
- Provide clinical care to patients in OPDs/IPD/Home care.
- Visit patients at homecare as per schedule and need of the patient.
- Provide clinical care to patients in OPDs/IPD/Home care.

- Participate in quality improvement initiatives to enhance palliative care services.
- Provide education and training to healthcare professionals in sensitization workshops.
- Lead multidisciplinary team meetings to discuss patient care plans and ensure comprehensive care.
- Collaborate with OPDs of other departments like Radiation Oncology, Pediatrics Oncology, and Gynae Oncology for comprehensive care plan the patients.
- Overseeing homecare services for patients with advanced diseases, ensuring that complex symptom control and end-of-life care are appropriately managed at home.
- Provide expert consultation for inpatients with palliative care needs, guiding symptom management and ensuring comfort.

- Managing complex symptom management cases such as refractory pain, end-of-life care and emotional distress.

2. Palliative Care Nurse

- Conduct comprehensive assessment of patients' physical, emotional, and social needs.
- Provide management of symptoms such as pain, nausea, and breathlessness.
- Administer medications as prescribed and monitor for any side effects.
- Educate patients and their care givers on palliative care, symptom management, and self-care.
- Provide clinical care to patients in OPDs/IPD/Home care and discuss with senior palliative care physician and palliative care doctor.
- Plan and conduct home visits to provide palliative care services to patients as per the need of the patient.
- Maintain up-to-date record of patients visited during home visits.
- Collaborate with the multidisciplinary team, including doctors, social worker, and other healthcare professionals.
