2. It is stated that last date for online bid submission on CPP Portal and physical submission of Hard Copy of Demand Draft and Technical document is hereby extended till **03 Oct 2022 (Monday), 12:00 PM.**
3. Further, it is to be categorically noted that the Financial Bid is required to be uploaded online only on CPP Portal and not to be submitted along with the hard copy of Technical evaluation documents. The Tender submitted may be liable to be rejected if Financial Bid is submitted along with Tender Fee and Technical evaluation documents.
4. A Pre-Bid meeting was held on 09 Sept 2022 at 11:00 AM at the Institute regarding the subject tender. The following queries/ requests were raised in the Pre-Bid meet. The reply from the Institute side is enumerated below: -

(a)	Requests to increase rates of some items in the proposed Menu	The revised Menu is attached with this Notice.
(b)	Requests to add and remove some items from Menu, keeping in view the local cuisine	
(c)	Query regarding status of refund of Performance Security Deposit in case the successful bidder wish to withdraw from the contract.	The following is hereby added in the 'Termination of Contract' clause given on page No. 17 of the bid document: - v. In case the successful bidder/ Licensee decides to withdraw from the contract/ Licence Deed midway without completing the award period as defined in the agreement, then Licensee can terminate the contract agreement/ Licence Deed by giving three (03) month's Notice period. In this case, the PBG shall be released by the Institute.
(d)	Whether the Licensee can utilise the outer space of the Cafeteria site?	The Licensee shall have no right to utilise the outer space of the Cafeteria sites. Only space as defined in the bid document shall be allowed to be utilised by the Licensee.
(e)	Whether any accommodation will be provided to the employees of the Licensee at the campus?	No accommodation shall be provided to any employee of the Licensee at the Institute.
(f)	Whether FSSAI Licence application submission acknowledgement will be considered valid, in case the FSSAI Licence has not been issued before the last date of Bid submission?	No change is recommended. The intending bidder should have the FSSAI Licence issued on or before the last date of bid submission.

4. The following clause is hereby added to Para No. 15 (**Signing of Contract/ Agreement**) on Page No. 11 of the Bid Document

“As the duration of the Lease Period is more than 01 year, the Licensee shall pay applicable stamp duty charges and registration fee for registration of the Licence Deed. The Licensee shall make arrangements for registration of the Licence at their own cost and resources”

5. Further, the exemption in payment of Tender Fee and EMD shall be allowed as per rules enforce.

6. Rest of the terms and conditions of the subject Tender document shall remain unchanged.
