1. Description of Items

2. Terms and Conditions

- Only authorized recyclers registered with CPCB/SPCB shall be eligible to participate. A copy of valid authorization must be attached with the quotation.
- The bidder shall quote the **rate per kilogram (₹/kg)** for the entire lot.
- The **highest quoting bidder (H-1)** will be awarded the order, subject to verification of credentials.
- The material will be handed over on **"as is where is"** basis.
- The successful bidder shall lift the material at their own cost **within 07 days** of issuance of the work order.
- Applicable taxes, if any, shall be borne by the bidder.
- AIIMS Bathinda reserves the right to reject any or all quotations without assigning any reason thereof.
- The Committee constituted vide Office Order No. I/2037/2025 dated 25.02.2025 shall supervise the quotation and disposal process.
